GUARANTY

Inconsideration of financial accommodations given or to be given to _____

(herein called "Customer" by Architectural Woods, LP (herein called "AWI") and in consideration of AWI's agreeing to deal with Customer, on behalf of themselves and the marital communities consisting of themselves and their respective wives, if married, the undersigned hereby jointly and severally guarantee payment to AWI of all liabilities and indebtedness which Customer has incurred or may incur or be under to AWI whether arising from dealings between AWI and Customer or from other or from other dealings by which AWI may become in any way a creditor of Customer.

AWI may apply all moneys received from Customer or otherwise or from collateral upon such part of a Customer's indebtedness as AWI may think best, without in any way limiting or lessening the liabilities of the undersigned under this guaranty.

AWI shall not be bound to exhaust its recourse nor to take any action against Customer or other parties on the collateral it may hold before being entitled to payment by the undersigned of all amounts hereby guaranteed, but may make such demands and take such actions as it deems advisable.

This shall be continuing guaranty and shall be binding without notice to the undersigned of its acceptance, and shall cover all liabilities which Customer may incur or be under until the undersigned shall have given AWI notice in writing to make no further advances on the security of this guaranty; provided that such notice by any one or more of the undersigned shall not lessen nor diminish in any way the liability of the undersigned on any indebtedness or liability incurred prior to receipt by AWI, of such notice, nor lessen nor diminish the liability of others of the undersigned who shall not give such notice: and in the event of such notice AWI may cease to make further advances to Customer.

Notice of default on the part of the Customer is hereby waived; and the undersigned jointly and severally agree to remain bound notwithstanding any extensions or renewals of any indebtedness or the liabilities hereby guaranteed or any part thereof; and consent is hereby given to AWI to make such renewals and extensions as AWI at its option may choose or grant or accept; and AWI may at its own option further compound and settle with Customer or any of the undersigned or other guarantor and surrender any securities which it may now or hereafter hold belonging to Customer, without notice to any of the undersigned and without affecting in any way the obligations of any of the undersigned to AWI.

The undersigned promise to pay AWI's reasonable collections and/or attorney's fees should this guaranty be referred to any licensed collection agency and/or attorney for collection or other proceedings.

If customer is a corporation, the undersigned guarantee and represent that they are stockholders, or directors or officers, and/or are financially interested in Customer, and if married, their marital communities are so interested.
